DECLARATION OF A VACANCY IN THE OFFICE OF THE SPEAKER OF THE NATIONAL ASSEMBLY

IT IS notified for the information of the general public that pursuant to Article 106 of the Constitution and Standing Order 5 of the National Assembly Standing Orders, the Office of the Speaker of the National Assembly shall become vacant upon the first sitting of the National Assembly on Thursday, 31st August, 2017 at 9.00 a.m.

Article 106 of the Constitution provides that there shall be a Speaker for each House of Parliament, who shall be elected by that House in accordance with the Standing Orders, from among persons who are qualified to be elected as members of Parliament but are not such members and that the office of the Speaker shall become vacant when a new House of Parliament first meets after an election.

Pursuant to Article 126 (2) of the Constitution, His Excellency the President of the Republic of Kenya and Commander-in-Chief of the Kenya Defence Forces has, *vide* Legal Notice No. 219 of 2017, notified that the first sitting of the National Assembly shall be held at the National Assembly Chambers, Main Parliament Buildings, Nairobi, on Thursday, 31st August, 2017 at 9.00 a.m.

Interested persons who qualify to be elected as members of Parliament but are not such members are therefore invited to submit their nomination papers for election.

The nomination papers can be collected from the Office of the Clerk of the National Assembly, First Floor, Main Parliament Buildings, Nairobi from Friday, 25th August, 2017 to Monday, 28th August, 2017 during working hours. The Office of the Clerk of the National Assembly shall also remain open on Saturday, 26th August, 2017 and Sunday, 27thAugust, 2017 from 8.00 a.m. to 5.00 p.m. for purposes of collecting the nomination papers.

Completed nomination papers, together with the curriculum vitae of the candidate and relevant supporting documents, should be submitted to the Office of the Clerk of the National Assembly at Main Parliament Buildings, Nairobi not later than 9.00 a.m. on Tuesday, 29th August, 2017.

NOMINATED MEMBERS TO THE NATIONAL ASSEMBLY AND THE SENATE

IN EXERCISE of the powers conferred by Articles 88 (5) and 90 of the Constitution, section 4 (n) of the Independent Electoral and Boundaries Commission, 2011, sections 34, 35, 36 (1) (a)-(d),4,5 and 6 of the Elections Act, 2011, Regulation 54, 55 and 56 of the Election (General) Regulations, 2012 and Regulation 26 of the Election (Party Primaries and Party Lists) Regulations, 2017, the Independent Electoral and Boundaries Commission gives notice to the public that the persons listed in the 2nd Column to the Schedules stand validly nominated to the National Assembly and Senate representing the Political Parties listed in the 6th Column to the First Schedule and 5th Column to the Second, Third and Fourth schedules respectively.

Each candidate reflects the appropriate number of qualified candidates and alternates between male and female, save for the women candidates under Article 98(1)(b) of the Constitution, in priority in which they were listed. The seats referred to in the schedules have been allocated in proportion to the total number of seats won by the candidates of the political party at the general election held on 8th August, 2017.

And that -

- (a) the name of the nominated member of the respective Political Party is listed in the Second Column to the Schedules;
- (b) the National Identification Card Number or Passport Number of every nominated member is indicated in the Third Column to the Schedules;
- (c) the Gender of the nominated member's Gender is indicated in the Fourth Column to the Schedules;
