RULES AND PROCEDURES

ARTICLE 1.1: NOMINATIONS/ ELECTIONS RULES AND PROCEDURES

- a) Unless otherwise stipulated nomination of gubernatorial senatorial, parliamentary and county candidates shall be by secret ballot. The party, however, through the Election Board and the NEC reserves the power to issue direct nomination as and when it deems fit and in the interest of party objectives.
- b) Upon dissolution of the nation assembly and / or county assembly NEC shall within 60 days convene the national election and nomination board (otherwise referred to as NEB or special committee for Nominations) for the purpose of nominating the party's candidates /s
- c) A party member wishing to be nominated as a senatorial, parliamentary and / or a county candidates must submit his /her name to the party branch executive committee or in the absence of a party branch to NEC within (14) fourteen days of the event necessitating such election.
- d) Registration of senatorial, parliamentary and county candidates shall be by a prescribed Form accompanied by registration fees.
- e) Application and nomination fees shall be determined by the NEC and communicated to the party members and potential aspirants from time to time and the election period to period. Such determination shall include graduated or possible waivers of fees to special interest groups.
- f) The Party Branch Manager shall forward the whole list of names such applicants to NEC within (14) days of the receipt thereof.
- g) Upon receipt of the list candidates by NEC, such list shall be forwarded with or without recommendation s to the party's special committee on nomination s.
- h) The party's special committee nominations shall then select and inform successful candidates and their names to NEC for formal nomination to contest national and /or county offices.
- i) The party special committee on nominations acting on the advice of NEC may in any of the aforesaid elections/s decide to support a join candidates with any of the other political parties
- j) All the candidates for by –election shall be nominated by NEC.
- k) The special committee on nominations shall organize and supervise the party's nomination process.
- Only paid up and registered party members will be considered for nomination.
- m) Have to fit the requirements of chapter six (6) of the constitution on leadership and integrity.

- n) Candidates wishing to contest any of the respective position must or may be required to recruit into the party at least 1% of the registry voters in their respective electoral area before issuance of certificate.
- o) Candidates must be citizens of Kenya and holder of a national identity or passport as may be subscribed by law.
- p) Must be registered as voter.
- q) Must be 18 years and above
- r) Must sign and abide by Agano cond of conduct.
- s) Be capable of presenting a positive image of the party to the public.
- t) Be qualified to stand in an election which he or she seeks under the provisions of the law for the law for the time being regulating and governing the conduct of election in Kenya.
- u) Have no criminal record.
- v) Have not been declared bankrupt under the law of Kenya.
- w) Pay prescribed nomination fees as shall be determined by NEC.
- x) Produce all necessary identification document required by the party.
- y) Candidates must also have proposer and a second who must be party members and registered party as voters.
- aa) Only registered party members who are also registered voters shall participate in the nomination process. Voters must produce their party membership card and elector's as voters.
- bb) The special committee on nominations shall appoint election officials whose characters is not questionable.
- cc) Party elections at the county shall be presided over by returning /presiding officers and any other officials determined by the special committee on nominations
- dd) Party election at the county shall be presided over by returning / presiding officers and any other officials determined by the special committee on nomination.
- ee) The returning / presiding officers shall take charge of electoral process guided by established and procedures and procedures.
- ff) The special committee on nomination s shall issue the schedule stipulating the dates and public venue for nomination of senatorial, parliamentary and county candidates.
- gg) The returning / presiding officers may organize to have all the voting equipment, materials and staff at the polling center before polling opens on the Election Day.
- hh) At the polling area voting shall start at 8.00a.m and end at 5.00 p.m.

- ii) At the commencement of the nominations the returning / presiding officers will indicate clearly on poster and announce the posts and names of all eligible candidates.
- jj) Ballot papers for the polling station may be informed of booklet.
- kk) Each shall write clearly and legibly the name of their preferred candidates(s) and deposit in the designated ballot box.
- II) The ballot box must be clearly and transparent.
- mm) Illiterate voters may be assisted by party agents to fill in the name of their preferred candidates.
- nn) All ballot boxes must be bearing the official stamp of the party.
- oo) The returning office shall make arrangements to start counting of votes immediately after 5.00 p.m.
- pp) Counting of votes will take place at the polling station, in the presence of candidates or their appointed agents.
- qq) Ballot papers which have more than one mark / name, such that it is not clear which candidate the voter intend to elect shall be considered spoilt and therefore void.
- rr) The returning officer shall enter the result of counting process in the prescribed form before announcing those results.
- ss) Once the results form in is completed the returning officer shall give a copy of the completed form to the candidates or their agents and then announce those results by reading from the completed form.
- tt) Candidates taking part in the elections and who is dissatisfied with the results shall be entitled to appeal to the special committee on nominations.
- uu) The special committee on nominations shall hear the presentations and decide each case objectively on its merit.
- vv) The decision of the special committee on nominations on such appeals shall be final.
- ww) Should be election be found to be flawed and therefore null and avoid, the special committee on nomination shall announce the dates and venue for fresh elections and conduct such repeat election in the manner prescribed above.
- xx) Returning / presiding officers shall file duly signed returns with the special committee on nominations not later than 2days after the announcement of results.
- yy) The form will specify the names and positions of elected county, parliamentary and senatorial candidates

- (xvi) Each return/ presidingofficer shall conduct democratic, free, fair, and transparent elections using the secret ballot method of voting.
- (xvii) The ballot box must be clear and transparent.
- (xviii) A voter shall be a Kenyan citizen who is party member and registered as a voter. The voter must produce valid documentation to prove this.
- (xix) The special committee on nominations shall issue a schedule stipulating the dates and public venues for party elections.
- (xx) The returning/presiding officer may organize to have all the voting equipment, materials and staff at the polling center before polling opens on the Election Day.
- (xxi) At the polling station voting shall start at 8.00 a.m and end at 5.00 p.m.
- (xxii) At the commencement of elections, the returning/presiding officer will indicate clearly on a poster and announce the post and names of all eligible candidates.

(xxiii) Ballot papers for the branch executive committee may be informed of a booklet that contains the party positions being contested. Each voter shall write clearly and legibly the name of their preferred candidate, tear of each (xxiv) ballot and deposit in the designated ballot box. (xxy)Illiterate voters may be assisted by the party agents to fill in the name of their preferred candidate. (xxvi) All ballot papers shall bear the official stamp of the party. (xxvii) The returning officer shall make arrangements to start counting of votes immediately after 5.00 p.m. (xxviii) Counting of votes will take place at the polling station, in the presence of candidates or their appointed agents. NATIONAL ELECTIONS AND NOMINATIONS BOARD (NEB) There is hereby established an organ of the Party called the National Elections and Nominations Board (NEB) Composition of NEB The National Elections Board shall be constituted by NEC and it shall consist of nine (9) persons of integrity appointed by NEC. 1. The Director of Elections and his or her deputy shall be ex-official members of NEB. 2. NEC shall appoint the Chairperson of the Board, the Director and Deputy Director of Elections on recommendation of National Management Committee; The Board at its first sitting shall appoint the Deputy Chairperson.

- 3. The Chairperson shall head the Board and preside over its meetings. The Deputy Chairperson shall in the absence of the Chairperson perform the duties of the office of the chairperson.
- 4. The Director of Elections shall be the Secretary to the Board. Members of NEB shall hold office for a period of one term of five (5) years, renewable once.
- 5. The Director of Elections, the Deputy Director and all other persons in the Board shall not seek office in the immediate general election.

Powers and Duties of NEB

- a. NEB may from time to time make rules, regulations, orders or notices for ensuring conduct of regular, free, fair, peaceful and transparent Party elections and nominations.
- b. NEB in consultation with the National Management Committee shall organize, coordinate and supervise all Party Elections and nominations I accordance with the Party Nominations and Elections Rules and Procedures.
- c. NEB, on recommendation of the NMC shall make, amend or alter Party Nominations and Elections Rules and Procedures.
- d. NEB shall appoint appropriate officers to conduct Party elections or nominations at the National Branch, Sub Branch, Ward and polling center levels.
- e. NEB shall vet Party nominees for appointment by the requisite Party. Organ to any position that the Party by law nominates to in consultation with the National Management Committee.
- f. The National Chairperson, Secretary General and the Deputy National Chairperson shall sign under seal the certificates of nominations. Any two (2) of the three (3) to sign.
- g. NEC shall cause an account to be opened in the name of NEB to collect all funds paid as nomination fees and direct all expenditure on the account.
- h. NEB shall consist of a Chairperson and eight other persons all of whom shall be of good standing and integrity and who shall not be seeking nominations as Party candidates in the Elections.
- i. In appointing the National Elections Board Members, the National Executive Committee shall have regard and ensure at least one third (1/2) representation of either gender in accordance with the Party Constitution and the Country's Constitution.
- NEB may establish dispute resolution panels at eh Branch,, Sub Branch, Ward and Polling Station levels. The panels are ad hoc in nature.
- k. Provided that where NEB has for any reason been unable to perform all or any of the duties specified herein above, the NEC shall assume all the Powers and duties of NEB.

- NEB shall be independent and act in accordance with the rules of natural justice, and in consultation with NEC.
- m. Carry out any other functions assigned to it by the NEC, NMC, NGC or NDC
- n. NEB in consultation with NEC shall collect all funds paid as nomination fees and direct all expenditure or remittance to the party in conjunction with NEC.

The National Election Board shall not have more than two-thirds of its members being of the same gender.

COMMISSIONS/COMMITTEES

Composition of Commissions and Committees

The commissions/committees shall be constituted by NEC on need basis.

Powers and Duties of Commissions/Committees

Their terms of reference shall be determined by the National Executive Committee.

ARTICLE 5: CODE OF CONDUCT

- 1. Members of Agano shall at all times strive to attain a society in Kenya in which people from different ethnic communities, age groups, political parties, religious and different economic backgrounds enjoy freedom, human dignity, security as well as basic needs such as adequate nutrition, clean water, shelter education and health care.
- 2. AGANO believes in the brotherhood and sisterhood of all people of Kenya and the world. Members of Agano shall accord priority to the poor and other vulnerable groups.
- 3. Members shall at all times bear the true allegiance to, and project a positive image of AGANO and its programs.
- 4. Members shall avoid any conduct at public, social and personal levels, which is likely to embarrass or compromise the image, aims and objectives of AGANO and its members.
- 5. Members shall avoid talking to non-members and the press about the affairs of Agano other than the target image, press strategy and issues which it has been agreed can be discussed.
- 6. Members of Agano shall NEVER engage in or propagate tribalism, sexism, racism or carry out a tribal agenda within or outside the party.

- 7. Member of Agano shall NEVER engage in theft, corruption, or misappropriation of the public property.
- 8. Members of Agano shall NEVER deceive the people with false promises, cheap propaganda, and/or buy their support with money.
- 9. Members of Agano shall tell the truth to each other, even when it is uncomfortable to do so.
- 10. Members of Agano shall NEVER falsely accuse or bear false testimony against another member.
- 11. Members of Agano shall promote a spirit of mutual respect, tolerance and constructive criticism among themselves, and members of other political parties.
- 12. All members of party organs shall be bound, to the principles of collective responsibility and will not conduct themselves in a manner that is inimical to the unity of Agano.
- 13. Members of Agano shall carry out assignments efficiently and in a transparent and accountable manner.
- 14. Members of Agano shall, to their best ability, assist fellow members whenever in need.
- 15. Members shall keep information privy to Agano to themselves even after ceasing to be members of the party.
- 16. Members of Agano will not get involved in violence as a means of promoting individual or party positions on any political matter.
- 17. Members of Agano will financially support the party in addition to doing so in kind and in additional to paying their monthly and/or annual subscriptions as set out by the relevant party organs and available in the party headquarters on request.
- 18. Elected and/or nominated members on the party ticket to any elective body, assembly or group must each successive month after such election or nomination start remitting their monthly and annual contributions to the party as set out by the party and as set out information available from the party headquarters on request by the affected members and, by being so elected and/or nominated under the party ticket is evidence enough of agreement and acquiescence to pay such monthly party remittances and annual subscriptions.
- 19. Members of Agano will not join another party whilst being members of Agano at the same time
- 20. By becoming a member of Agano, you agree to be bound by this code of conduct and to obey any disciplinary measure from NEC if you contravene this code of conduct.

ARTICLE 6: INTERNAL PARTY DISPUTE RESOLUTION MECHANISM.

Dispute resolution will be at three (3) levels. These are Sub Branch, Branch and National.

Decisions at the sub branch shall be appealed against at the branch, those of the branch at the National whereas those at the National level shall be final.

Procedure:-

- Complaints against Governor(s), Deputy Governor(s), MP(s), Senator(s), Members of County Assemblies (MCA's) and National official(s) shall be heard and determined at NEC. The NEC, however, shall have the power to hear any other disciplinary, expulsion, and recalling or cessation matter from any level.
- Complaints against County Assembly Official(s) and the branch official(s) will be heard and determined at BEC.
- Complaints against sub-branch, ward and polling station officials will be heard and determined at SBEC.
- Once the complaint has been received by SBEC, BEC or NEC; they will be under duty to inform the accused.
- SG/Secretary to SBEC, Secretary to BEC to avail the request to constitute the dispute resolution committee within 7 days upon receipt of the same.
- Within 7 days, the party accused may apply in writing to SG or Secretary to the branch or secretary to the sub- branch (as case may apply) for a dispute resolution committee to be constituted to attempt to resolve the dispute.
- Upon receipt of the request from the accused party, the SG or Sec to the branch or secretary to the sub-branch shall constitute the dispute resolution Committee instead of disciplinary committee.
- When request not received within 7 days, the SG or the secretary to the branch or secretary to the sub- branch shall constitute the disciplinary committee.
- Committee shall have a minimum of 3 members. (Shoot in/shoot out mechanism to apply-accused party is allowed to have a nominee on the committee.
- Within a period of one week if no resolution has been reached at the dispute resolution mechanism level, the SG or secretary to BEC or secretary to SBEC, shall constitute the disciplinary committee.
- The dispute resolution mechanism provided may extend for another 7 days where necessary. The reason(s) for such extension shall be communicated in writing to all parties concerned.

- It shall be an act of gross misconduct for any member of the party to disregard the dispute resolution and disciplinary mechanism under this Constitution and proceed to court or any other body without exhausting the internal dispute resolution mechanism. Such an act shall earn that member an automatic expulsion from the party. The member so expelled vide this proviso, shall bear the legal costs of the suit filed in any court or any other body.
- The NEC shall also have the powers to institute disciplinary proceedings on its own or on its volition and/or motion against every or any party member or specifically against elected or nominated members in an election provided for by-the Constitution of Kenya. The NEC will employ its own procedures of instituting and hearing a dispute, key among them, applying the rules of natural justice.
- The Disciplinary Committee in addition to, NEC or NGC shall have power to make a decision to expel, recall, cease membership or discipline in such other may it deem fit.
- The Disciplinary Committee shall be made of a minimum of three (3) members, at least two (2) being NEC members.
- Written communication from the party calling the members against whom a complaint has been raised or a problem identified, shall be sufficient to institute proceedings and service may be sufficient if effected by post, email or physically dropped at members home, office or place of official meetings.
