### **POLITICAL PARTY NOMINATION RULES**

- 1. Under Article 10 of the EFP party Constitution, EFP Elections board is hereby established to conduct and supervise party nominations**
  - 1.1. To conduct party elections for National and County office bearers
  - 1.2. Conduct party nominations for candidates vying for presidential, parliamentary, and county elections on the party ticket
  - 1.3. Develop the party elections strategy and policy and forward the same to the NPA through CMC for ratification
  - 1.4. Establish party elections rules and regulations governing party elections and nominations and nomination procedures and forward the same to the NPA through CMC and National Summit
  
- 2. The Party shall appoint**
  - 2.1. Chairperson of the NEB
  - 2.2. The Secretary General NEB
  - 2.3. Five other Members appointed by the party structures and ratified by NPA
  
- 3. The two-Thirds gender rule is mandatory hence under the Director of Elections Jibril Maalim Mohamed, the rest of the committee is as follows**
  - 1) Ali Ibrahim Mohamed – Chairman
  - 2) Pamela Jeptoo Kugun - Secretary
  - 3) Lillian Stella Muli
  - 4) Abdullahi Sheikh Mohamed
  - 5) Abdikadir Birik Aftin
  - 6) Fahmi Gedow Hassan
  - 7) Alibashir Tullo Ali

**4. Appointment period:**

The NEB shall be appointed and act for the period of the general elections and as per the IEBC timelines of the ensuing general elections 2017

**5. Several methods have been used to identify candidates;**

- 5.1. Candidates walking in
- 5.2. Advertisement in the media
- 5.3. Seconded
- 5.4. Guided democracy
- 5.5. By consensus
- 5.6. By demand

**6. Detailed procedures in identifying aspiring candidates for the party**

- 6.1. Direct nomination
- 6.2. Consensus
- 6.3. Secret ballot where required

**7. Party Nomination Fees for Special Interest Groups**

- 7.1. Special Interest Persons – 25,000/=
- 7.2. Women Aspirants (Parliamentary Seats) - 70,000/=

**8. Detailed Procedures for the conduct of party nominations**

- 8.1. Identify candidates in areas requiring nomination
- 8.2. Provide rules, dates and venues for the nominations
- 8.3. Conduct the nomination in an agreed formula between the aspirants
- 8.4. Declare winner(s) and forward candidates to the party for certification and onward forwarding to IEBC

**9. Party conduct of party list nominations as guided by Article 90**

- 9.1. Minority and marginalized persons shall be prioritized
- 9.2. Two-third rule shall be adhered to

9.3. Special interest persons shall be considered

9.4. Central Management Committee shall guide the NEB on the appointments to be made

**10. Direct Nominations; The party shall conduct direct nominations and proceed to issue nomination certificates where**

10.1. A successful consensus between aspirants has been reached

10.2. Successful interviewees


10.3. A single candidate

10.4. For purposes of fulfilling the requirements for the two-thirds gender rule and special interest person

**11. Aspirants' Agents**

11.1. In applicable circumstances each aspirant shall provide a list of their agents who they will accredit for the purpose of the nomination exercise

11.2. Where possible and with prior arrangements agents for aspirants can be trained on conduct and security of the nomination exercise
