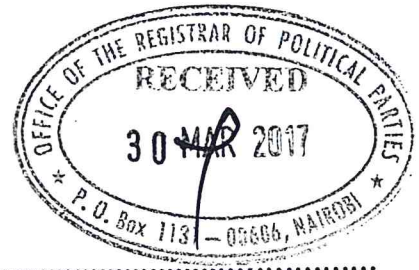


NOMINATION RULES

1. The party shall nominate presidential, governor, senator, women representative, MPs and members of county assembly candidates who must be registered members of the party.
2. The candidate shall pay nomination fees as follows:
 - a) Presidential Kshs 1000000/=, membership cards 5000@20/=each
 - b) Governors Kshs 1000,000/=membership cards 1000@20/=each
 - c) Senators Kshs60,000/=membership cards 500@20@/=each
 - d) Women Rep Ksh 50,000/=membership cards 500@20/=each
 - e) Parliamentary Ksh 50,000/=membership cards 500@20/=each
 - f) Member of county assembly Kshs 20,000/=and 250 membership cards@20/=each
3. Incase an area has elected MCA and there is need for nomination of an mca the part shall nominate wiyh priority given to a founder member
4. The party shall have the powers to nominate an MCA from among those who have contributed to the development of the party
5. Incase there are more aspirant for a seat, they will be nominated through secret ballot by paid up party members. The candidates shall meet the costs in their branch/ward
6. People's party of kenya through the national elections board which consist of five people with a chairperson, Shall in combination with dispute resolution committee solve dispute arising from election or party primaries.



7. Any person can be on party list and primaries, that is an Executive member or a NEC member.
8. Must be a member for not less than six months.
9. Must Fulfil chapter six of Integrity.
10. The party shall submit to the commission the signatures of the persons authorized by the party.
11. The party has a right to recall an elected person or nominated to any seat if the person crosses to another party.
12. All membership cards sold by the party must bear the signature of the National chairperson or Secretary General to avoid sale of fake cards.
13. Any aspiring candidate must sign and strictly adhere to the party code of conduct and nomination rules before being nominated to vie for any seat.
14. If a candidate win an election, he/she must be paying 5% of his/her monthly salary to the party to assist in running the party.

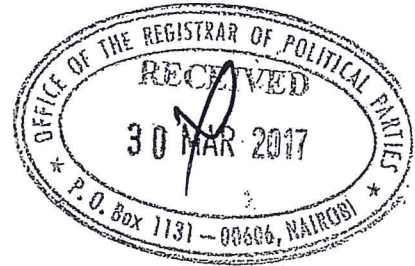

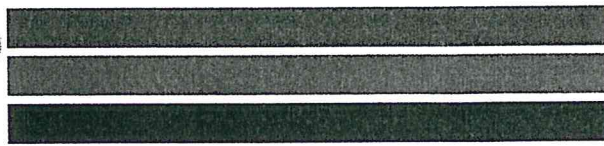
